From the Beginning

About Us

David Watson Transport Ltd started off life as Milbank Trucks Ltd in 1986.

David Watson started as a driver for Milbank Floors Ltd (part of the Milbank group of companies) which was established in 1947 near Chelmsford in Essex. Manufacturers of precast concrete units to designs patented by Geoffrey Milbank. 1985 saw the Company move to a modern purpose built factory on an 8 acre site at Earls Colne. January 1984 saw the purchase of the first lorry under the Milbank Floors banner. The lorry was the first of its kind to be fitted with a Tico lorry loader arm, equipped with a winch to allow it to be used in the same manner as a mobile crane.

In July 1986 Milbank Trucks Ltd was formed as a separate company with David Watson as the Managing Director. Steps were taken to develop the company from a specialist in the delivery of concrete flooring products to taking on other work requiring the use of a heavylift crane lorry. In 1988, an 8 wheeled rigid lorry, fitted with a 30 ton/metre crane – the largest of its type at that time – was purchased with the specific aim of being able to lift heavier plant and equipment than any of the competitors.

Milbank Trucks continued to expand, with over 115 trucks in the fleet and over 140 employees. Depots at Earls Colne, Brandon, Cliffe, Stafford and Northampton gave the company great coverage throughout the United Kingdom allowing a fast and efficient response to customers' demands. In November 2008 Milbank
Trucks was placed into administration as a result of the failure of sister company
Milbank Floors Ltd due to the decline in the building industry. Because the company had been successful, the administrators and banks fully supported a takeover by David Watson and his team so December 22nd 2008 David Watson Transport Ltd completed the purchase of the assets of the company formerly known as Milbank Trucks Ltd.

Since the very beginning the company has achieved continuous and successful growth and through hard work and unrivalled service are still one of the largest specialist crane

truck hire companies in the UK, enjoying an enviable reputation whilst continuing to set the standards for others to follow.

Now no longer part of the group of companies the business has moved on, in the right hands. With nearing 100 trucks in the fleet, 120 employees and depots at all 5 locations still, David Watson Transport provide their customers with a nationwide service and expertise that allows a fast, efficient and economical response to customer needs

We have considerable experience of rail-side work, having spent over six years on a specific contract for GTBBJV (GT Rail Maintenance & Balfour Beatty Rail Projects Ltd's Joint Venture), who were the major contractor for the West Coast Main Line upgrade.

Whilst the nature of our operations means we will never operate near railway lines without some supervision, such as a COSS (Controller of Site Safety), we have taken steps to ensure our operators understand rail-side safety requirements by having a significant number trained in Personal Track Safety, providing them with PTS cards.

We are an approved rail-side provider, having completed the Achilles Link-Up, and passed the Qualified Audit process. We are therefore able to sponsor ourselves for additional qualifications, as well as having direct access to the NCCA (National Competency Control Agency) Sentinel website.



Lifting Operations

Appointed Persons & Slinger Signallers

When hiring equipment to perform any lifting operation you have two options; to Hire and Manage the lift yourself, or Contract Hire where the organization hiring you the equipment takes full responsibility for the lifting operation.

To Hire and Manage, there must be someone in your organization that has knowledge, experience and understanding of lifting operations – a person appointed to be in control of lifting operations, or an appointed person.

For clients that have no knowledge, experience or understanding of lifting operations your only option is a Contract Lift, where the organization hiring the equipment to you will take full responsibility for the lifting operation with their own appointed person.

We have qualified Appointed Persons (Lifting Operations) within our organization to take responsibility for all of the lifting operations we perform.

The Lifting Operations and Lifting Equipment Regulations state that 'all personnel involved in a lifting operation must have adequate knowledge, experience and understanding of lifting operations for a safe lift'.

A safe lifting operation involves more than a trained and competent lorry loader operator; it means there has to be a level of planning of any lifting operation and that the people doing that planning must also have knowledge, experience and understanding of how to plan a safe lift.

We offer this service individually, controlling lifting operations on clients sites, from commencement of a project through to completion or as part of a 'one-stop-shop' lifting operation.

We also have CPCS and ALLMI qualified Slinger/Signallers available to perform slinger/signaller duties when you have nobody available or with the relevant knowledge, experience and understanding of the duties of a slinger/signaller.

Reducing the Risk

Method Statements / Risk Assessments

The Management of Health and Safety at Work Regulations states that all work-based activities that have significant risks attached must be assessed, and the identified risks must be eliminated or reduced so as to pose no further significant risk. This means conducting a risk assessment.

Where significant risks remain after completing the risk assessment, a Safe System of Work (Method Statement) must be compiled that clearly shows how the people involved in the task

should accommodate the residual risk and complete the task safely. Where the tasks are regular and repetitive the Safe System of Work may be recorded as a generic document that requires periodic review or revision when circumstances change significantly. For other tasks that are unusual or 'one-offs' a site-specific method statement must be produced.

David Watson Transport has a number of risk assessments and method statements prepared as generic documentation for many of our lifting operations, but with the expertise of those involved in compiling those we can offer the service to others.

This legislation applies to all shippers, road carriers, air carriers, freight agents and handling agents who are involved in road transport of dangerous goods above the limited quantity exemptions.

- However, the generic documents can be easily amended to convert and make them site-specific;
- Operators are trained in conducting on site risk assessments prior to performing any lifting operation;
- Our operators have attended Construction Skills Health and Safety Touch-screen test;
- In addition to holding an ALLMI lorry loader licence (the only lorry loader training to have a 'Working in Partnership with HSE' accreditation) our operators hold CPCS (Construction Plant Certification Scheme) cards;
